



MEDICAL REQUIREMENTS AND PROCEDURES FOR NEW ZEALAND VISA APPLICANTS

LIST OF REQUIREMENTS

Please know your visa category and type before booking an appointment.

- ① For application-first medical process: Please bring your **Letter/Medical Instruction from INZ bearing your INZ Health Case Reference (NZHR)**
 - If you are applying for a Visitor Visa or an AEWV, you can view this letter by logging in to your Immigration Online account. You can find your NZHR under the heading 'INZ Health case reference'.
- ② **Original passport and a photocopy of the bio page**
 - If the passport is not available, please inform us via email at mhc.nz@iom.int before your appointment date.
- ③ **One (1) Government-issued ID for the Trafalgar building access pass**

ADDITIONAL REQUIREMENTS

For Applicant 0-18 yrs. old

- ① Kindly bring **PSA Birth certificate** and photocopy

Minor applicants accompanied by the parent

- ① Parent to bring two (2) valid Government-issued IDs for the clinic and Trafalgar building access pass

Minor applicants accompanied by a guardian (not the parent)

- ① **Letter of Authorization** from the minor's parent (signed) and a scanned copy of the parent's passport
The Letter of Authorization can be scanned and then emailed to the guardian by the parent. The guardian can print the said document and bring it on the day of the minor's appointment.

- ② **2 valid Government-issued IDs** of the guardian for the clinic and Trafalgar building access pass

For applicants who are required of HIV Testing

- ① Fill out and print the HIV Personal Information Sheet and HTS Counselling Form which can be downloaded from the IOM Manila Health Centre Website <https://philippines.iom.int/manila-health-center> (see downloadable forms)

**Signature will be affixed on the day of appointment.*

For Pregnant Applicants

- ① To fill out (1) Pregnancy Declaration with Last Menstrual Period (LMP).

Prior to taking a chest x-ray (CXR), it is highly recommended that you consult with your Obstetrician who is in the best position to give advice on your individual medical status. All pregnant clients after being counseled by the MHC Panel Physician can decide on either of these two options:

- Defer the CXR and therefore the finalisation of both IME and visa application, until after giving birth
- Proceed with the CXR, with appropriate abdominal and pelvic double lead shielding, after completion of the first trimester.

For applicants who have been vaccinated

- ① Kindly bring your **vaccination card** on the day of your appointment.

Important Reminders:

- *If applicants have significant medical history or undergoing treatment, kindly bring pertinent medical reports/results.
- *Please bring your eye glasses or contact lens, if applicable.
- *No fasting is required. No specimen samples should be brought.
